In compliance with the provision of Regulation 30 read with Schedule III of SEBI (LODR) Regulations, 2015 and any other applicable regulation, as amended, this is to inform you that the Board of Directors of Indian Renewable Energy Development Agency Limited (IREDA) in its meeting held **Today, August 22, 2026**, inter-alia, has accorded approval for changes in the Senior Management Personnel of the Company in view of the organizational requirements and administrative exigencies. Pursuant to which, Shri Bhagirath Siyag, General Manager (Projects); Shri Sujith V Surendran, General Manager (Projects); Shri Koushik Goswami, General Manager (Projects) and Shri Pradipta Kumar Roy, Additional General Manager (Projects) ceased to be Senior Management Personnel of the Company w.e.f. August 22, 2026.

Further, in reference to our earlier letter dated May 29, 2026, wherein it was informed that the Board of Directors of IREDA in its meeting held on May 29, 2026, inter-alia, have recommended final dividend of ₹0.75/- per equity share, i.e., @ 7.50% on the face value of the paid-up equity share of ₹10/- each for the FY 2025-26, subject to approval of shareholders at the ensuing Annual General Meeting (AGM) of the Company. Pursuant to the Regulation 42 of SEBI (LODR) Regulations, 2015, it is hereby informed that the **Record Date for the said final dividend has been fixed as Friday, September 11, 2026** for the purpose of ascertaining the entitlement of members for payment of Final Dividend. If the final dividend as recommended by the Board of Directors is approved at the ensuing AGM, payment of such dividend subject to the deduction of tax at source, will be made within 30 (Thirty) days from the date of approval of the shareholders in the ensuing AGM.

It is to further mention that as per provisions of Income Tax Act, 2025 (the Act) read with relevant rules, dividend income is taxable in the hands of shareholders and the Company is required to deduct tax at source (TDS) at the time of making payment of dividend, at the rates prescribed in the Act. However, in case a shareholder wants that his/ her/ its tax should be deducted at lower rates, or no tax should be deducted in accordance with Income Tax Act, 2025, then he/ she/ it should submit scanned copy of requisite documents **on or before September 11, 2026** at <https://web.in.mpms.mufig.com/formsreg/submission-of-Form-121-41.html>

It is also informed that no communication regarding the tax determination/ deduction of tax at lower rates shall be entertained after September 11, 2026. Further, incomplete documents and/ or documents submitted through any mode other than the prescribed mode shall not be considered.

Further, it is pertinent to mention that pursuant to the recent amendments in the SEBI (LODR) Regulations, 2015, the dividend payment shall be made exclusively through electronic mode. The provision for remittance of dividend via physical instruments such as cheques or warrants has been discontinued. In view of the same, members are therefore requested to approach their respective Depository Participant (DP) to register or update their bank account details in their demat account, in accordance with the procedure prescribed by the DP, to facilitate smooth and timely credit of dividend.

Details regarding taxation of dividend will also be available on the website of the Company at <https://www.ireda.in/> under the 'Investors Tab'.
