# Modi's 26-km roadshow brings Bengaluru to a halt

City believes in us to deliver good governance, said PM in a tweet

WITH just four days left for the big day, Prime Minister Narendra Modi launched a massive 26-km roadshow in Bengaluru to reach out to voters and win as many seats as possible for BJP in the state capital.

The roadshow disrupted traffic in parts of the city. Commercial activities were also hit as shops and other establishments remained shut till the roadshow ended.

The BJP, which termed the roadshow a historic one, estimated that around eight lakh people witnessed it.

Modi, who arrived at Someshwara Bhavan at JP Nagar, was welcomed by BJP MPs PC Mohan and Tejasvi Surya. Wearing a saffron 'Mysuru Peta', the PM began his roadshow, covering 13 of the 28 Assembly constituencies in the city.

An energetic Modi kept waving at the crowd while folk artists performed 'Veeragaase', 'Dollu Kunitha', 'Kamsale' and 'Thamate' along the route.

A large number of people, in-

cluding children, participated in the roadshow. Many were seen wearing Modi masks and holding his posters and cut-outs. Chanting slogans, they showered petals on Modi.

A huge statue of Lord Hanuman was mounted on a vehicle at Sirsi Circle and people wearing the costumes of Lord Rama, Lord Lakshmana and Lord Hanuman were seen chanting "Jai Bajrang Bali". This was in re-

sponse to Congress' announcement in its manifesto that it will ban organisations such as Bajrang Dal. The three-hour roadshow ended on Sampige Road in North Bengaluru.

Overwhelmed by the response, Modi tweeted, "It is clear Bengaluru wants BJP. This city believes that our party will continue delivering on good governance and development."

# Congress will return money looted by BJP: RaGa

FORMER AICC president Rahul Gandhi on Saturday lashed out at the BJP for forming the government by "horse trading", and breaking "all records of looting" over the last three years.

"We want to return the money looted from people. Thousands of crores looted will be deposited in their accounts," Rahul said, addressing a rally in Bhutaramanahatti village in Yamakanmardi constituency.

"Prime Minister Narendra Modi was silent after the Contractors' Association wrote to him, alleging that 40% com-

mission has to be paid to carry out civic works. A BJP MLA has claimed that the chief minister's post can be purchased by paying Rs 2,500 crore to BJP. There are scams everywhere in the BJP government including in PSI and assistant professors recruitment and cooperative banks," he said.

Former Congress president Sonia Gandhi appealed to people in Hubbali to get rid of the BJP government, saying, "There cannot be any development either in Karnataka or in the country in this atmosphere

of hatred, loot and lies created by the BJP government."

Calling the central government "despotic", the Rae Bareilly MP said, "The country has never seen a government which does not answer any questions and undermines the supremacy of the Parliament. How can democracy survive?"

Emphasising on Congress guarantees, she said, "The governments in Rajasthan, Chhattisgarh and Himachal Pradesh have already fulfilled the promises. The party would do the same in Karnataka."

Rahul said that inflation is at an all-time high in the country along with skyrocketing prices of LPG cylinder and fuels, adding that Modi did not intervene where there was flood in Karnataka and failed to resolve the interstate water dispute.

"Prime Minister Modi has never told the people what his plans are for the state for the next five years. He talks about terrorism, but I know more about that than him. I have lost my grandmother and father to terrorism," he said.

KPCW working presidents Saleem Ahmed and Satish Jarkiholi also spoke on the occasion.

# 10 Lankan Tamils landed in India seeking refuge

A total of 10 Sri Lankan Tamils, including four children and four women, were rescued from the first sand bar near Dhanushkodi on Saturday. With this, the total number of Tamil who have arrived in India since March 2022 has gone up to 254.

Following information, Marine police rushed to the spot and brought the people to the shore with the help of local fishers. They were provided primary aid and have been lodged in Mandabam refugee camp after inquiry.

The police found that they were from Mullaitivu region in Sri Lanka and had arrived in India hoping to get a better life. They said that they had paid ₹1.5 lakh for the ferry to India.

Speaking to TNIE, Jacintha Lazarus, Commissioner of Rehabili-

tation and Welfare of Non Resident Tamils, said, "The Sri Lankan Tamils are accommodated and provided with basic amenities at Mandapam camp under humanitarian basis. The children were enrolled in local government schools to continue their education. Few people have expressed willingness to return to Sri Lanka and we are considering their appeal."

Meanwhile, according to Sri Lankan Navy sources, the Sri Lanka Navy has apprehended six persons suspected of illegal immigration to a foreign country via sea on Saturday.

The apprehension was made during a search operation conducted off Erukulampiddi, Mannar on May 5. The suspects are identified as residents of Vavuniya and Mannar areas. They were handed over to Mannar Police.

# SC plans glossary on gender inappropriate terms

CHIEF Justice of India DY Chandrachud on Saturday said the Supreme Court will soon launch a legal glossary on gender inappropriate terms.

The CJI said the Supreme Court had launched a new initiative - IJURIS (Integrated Judicial Upgradation and Reforms on Infrastructure and Services) to not only improve

judicial infrastructure at both micro and macro levels but also attune it to contemporary needs.

Under the initiative the apex court had recently launched the LGBTQ handbook. "We are almost on the anvil of launching a legal glossary on gender inappropriate terms," he said.

"If you read a judgment on 376, I am sure all of you have come across phrases that the

'victim was ravished by the appellant' or in a bail order in an NDPS case that 'the negro was...'. Judges do that unwittingly," the CJI explained.

"I am not saying there is a bias in our minds. The purpose of the legal glossary is not to belittle our judiciary but to make aware that in the time we are living in, we pay as much attention to language as to substance," the CJI explained.
