Indian Renewable Energy Development Agency Ltd. (IREDA) presented a cheque of  $\stackrel{>}{\sim}105$  crore towards the interim dividend for the financial year 2017–18.

Approval of Initial Public Offer (IPO)

- Cabinet Committee on Economic Affairs (CCEA), on 7 June 2017 approved IREDA's Initial Public Offer for raising fresh equity by way of issuing shares to public aggregating to 13.90 lakh shares of ₹10 each.
- Draft Red Herring Prospectus of IPO filed with BSE/NSE on 22 December, 2017.





London Stock Exchange welcomed Indian Renewable Energy Development Agency's (IREDA) first green Masala bond on 29 September 2017. The five year dated Green Masala Bond raised approximately \$300 million (₹19.5 billion) with a coupon of 7.125 per cent and becomes the first green Masala bond to be listed on London Stock **Exchange's International Securities** Market (ISM). The green bond is certified by Climate Bonds Initiative, an international, investor-focussed not-for-profit, which helps build robust and transparent assurance frameworks around green bond investment.

The money raised from IREDA green bond will go towards financing renewable energy projects across the country. This is the fourth green bond by an Indian issuer to be issued on London Stock Exchange. Axis Bank and National Thermal Power Corporation (NTPC) joined in 2016 raising respectively, \$500 million and \$300 million equivalent. In June this year REC raised \$450 million. In 2015 London Stock Exchange launched its dedicated green bond segments creating strict admission criteria aligned with ICMA's Green Bonds Principles. There are 48 green bonds listed in London that have raised over \$13 billion in aggregate terms across seven currencies. Ten new green bonds have been listed on London Stock Exchange in 2017 alone.

Chairman & Managing Director of IREDA, Shri K S Popli, together with Secretary, Ministry of New and Renewable Energy, Shri Anand Kumar and Minister of State for Universities, Science, Research and Innovation of United Kingdom, Jo Johnson, joined Xavier Rolet, CEO of London Stock Exchange Group opened trading in London on 29 September morning.



# **■ IREDA's Solar Power Project**

- The project has been set up at Ambalathara Village, Kasaragod District, Kerala and is exporting power to the grid. Revenue to the tune of ₹20.03 crore earned during the FY 2017–18.







Indian Renewable Energy Development Agency (IREDA) Ltd., the World Bank, and Department of Economic Affairs, Government of India (GoI) have signed the International Bank for Reconstruction and Development (IBRD) loan agreement of \$75 million, Clean Technology Fund loan agreement of \$23 million and Clean Technology Grant Fund of \$2 million to support lending by IREDA to the Shared Infrastructure for Solar Parks Projects in India.

IREDA Signs \$100 million Loan Agreement with World Bank to Support Shared Infrastructure for Solar Parks Project in India

The loan agreement with the Government of India guarantee has been signed between Mr Sameer Kumar Khare, Joint Secretary (MI), Mr Hisham A. Abdo Kahin, Acting Country Director, the World Bank and Mr K S Popli, Chairman and Managing Director, IREDA, on 20 November 2017, at the office of Department of Economic Affairs, Ministry of Finance, North Block.

The World Bank has so far invested \$61.8 billion funds in loans, grants, equity investments, and guarantees to partner countries and private businesses worldwide. World Bank line shall provide long term funds for development of shared infrastructure which will help in lowering the cost of project and thereby cost of generation of power and help the sector towards achieving development of 20 GW through Solar Parks out of overall target of 60 GW for ground-mounted solar.



IREDA and RUMSL Signs Agreement for Large-Scale Solar Parks in Madhya Pradesh





Indian Renewable Energy Development Agency Ltd (IREDA) and Rewa Ultra Mega Solar Ltd (RUMSL) signed an agreement for financing the shared infrastructure of two large solar parks in Madhya Pradesh on 31 January 2018.

Ministry of New & Renewable Energy (MNRE), the World Bank & IREDA have been able to work out a proposal to channelize US\$ 100 Million for a creating common infrastructure for ultra-mega solar parks in India to achieve the 100 GW solar capacity addition target by 2022, set by the Hon'ble Prime Minister Shri Narendra Modi. Under the World Bank Line of Credit, IREDA has sanctioned its first loan of ₹210.62 crore to RUMSL to finance two such solar parks in the state of Madhya Pradesh. The agreement was signed by Shri S K Bhargava, Director (Finance), IREDA and Shri Avaneesh Shukla, Executive Engineer, RUMSL in the presence of Shri Upendra Tripathy, Interim Director General, International Solar Alliance (ISA).

The broad terms and condition of the agreement include fixed interest rate of 8.5% p.a. for entire loan tenure, moratorium from principal repayments upto 5 years, and loan repayment period of upto 20 years.

Speaking on the occasion, Shri K S Popli, CMD, IREDA appreciated the initiative of MNRE, support of The World Bank, and more specifically of DEA to reduce the Sovereign Guarantee fee to 0.5%. He further stated that this support from DEA will enable to fund solar parks at lower rate of interest and expedite development of such proposals in other states also.





European Investment Bank (EIB) and Indian Renewable Energy Development Agency Ltd. (IREDA) have signed a loan agreement for a second line of credit (LoC) of €150 million on non-sovereign basis at The Leela Palace, New Delhi, on 10 March, 2018. The line of credit is for tenure of 15 years, including a grace period of 3 years, and will be used for financing renewable energy and energy efficiency projects in India. More than 1.1 million households are expected to benefit from clean energy produced with these funds. The loan agreement was signed

Highlighting the fact that renewable energy (RE) has now become economically viable, he said that companies bidding for RE projects are getting funds from all over the world.... Today, many countries want us to share our experience in this field."





#### ■ NSE IFSC lists IREDA's Masala Bonds

In an event organized by National Stock Exchange on 16 March 2018 at Mumbai, Debt Capital Market operations of NSE IFSC were inaugurated by the Executive Director, SEBI, Shri S K Mohanty. In the same event, IREDA's Green Masala Bond of an aggregate amount of ₹1950 crore were listed on the said new platform 'Debt Securities Market of NSE IFSC'.

IREDA is the first issuer of Masala Bond which has been listed on NSE IFSC platform. The listing will offer high cost efficiency as well as enable issuers to access international investors. This listing is a great opportunity for Indian issuers going overseas to attract international investors in their home country.

IREDA Green Masala Bond were issued in October last year and were listed at London Stock Exchange and Singapore Stock Exchange. An amount of USD 300 million (₹1,950 crore) was raised through issue of these bonds from MTN Program.

Proceeds from the issues were used to finance renewable energy projects across India. Masala Bonds are bonds issued outside India but denominated in Indian Rupees, rather than the local currency.



- Non-fund partial credit guarantee instrument
- Instrument helps the project to raise funds through bonds at:
  - Reduced interest costs
  - Longer tenor of Loans
- Release exposure limits with banks and FIs





#### New Financial Products Launched

#### **Guarantee Assistance Scheme to RE Suppliers/ Manufacturers/ EPC Contractors**

- >> Non-fund-based assistance by way of extending guarantees for the performance of activities/ contractual obligations related to renewable energy projects.
- >> The guarantee can be extended to cover the tender bid security amount and/or to cover the advance payment received against the contract to execute the renewable energy project.




