



Shri Vishnu Shankar Prasad, filed an appeal dated 13.09.2018 (received on 17.09.2018) under the Right to Information Act, 2005 with the Appellate Authority against the reply of Central Public Information Officer (CPIO), IREDA Limited seeking following information.

- i. State the terms and reference for granting financial assistance of Rs.48.65 crore on 30.10.2003 to M/s Sterlight Fincom Pvt. Ltd.
- ii. State the purpose as stated in the file records for granting this Rs.48.65 crores loan / financial assistance from Government Exchequer to this private finance company.
- iii. State the period by which the principal amount of Rs.48.65 crores was to be deposited/

3) It is observed that the CPIO has examined the request made by the appellant based on the information supplied to him by the concerned department. The information furnished by the concerned department is reproduced as under.

“There is no customer in the name of Sterlight Fincom Pvt. Ltd. in the books of IREDA”

4) **Ground for appeal:**

- a) That the CPIO vide letter No.216/94/MS/2005/IREDA/3379 dated 07.09.2018 has wrongly and illegally denied the information by stating that “There is no customer in the name of Sterlight Fincom Pvt. Ltd. in the books of IREDA”.
- b) That the CPIO has stated false and incorrect information with apparent motives to deny and block the information is evident from the ‘Index of Charges’ posted by the Ministry of Corporate Affairs, Govt. of India on its website in respect of M/s Sterlight Fincom Pvt. Ltd.


(CIN No.U67120MH1999PTC103090) which clearly shows that an amount of Rs.48.65 crore was received by the Company M/s Sterlight Fincom Pvt. Ltd. on 30.10.2003 from M/s IREDA

5) **Observations and decision:**

- I have perused the records and relevant provisions of the Right to Information Act, 2005 and find that the CPIO has provided the correct information based on the input provided by the concerned department stating that "There is no customer in the name of Sterlight Fincom Pvt. Ltd. in the books of IREDA". As per Books of Accounts maintained at IREDA, no loan was advanced to M/s Sterlight Fincom Pvt. Ltd. Thus, the first ground of appeal (a) stating that the CPIO vide letter No.216/94/MS/2005/IREDA/3379 dated 07.09.2018 has wrongly and illegally denied the information is incorrect as there is no borrower in the name of Sterlight Fincom Pvt. Ltd. in the books of IREDA.
- As regards, second ground of appeal referred above at point (b) above, it is observed that as per 'Index of Charges' available on the website of Ministry of Corporate Affairs, Govt. of India, one charge ID bearing No. 80059755 is registered by M/s Sterlight Fincom Private Limited in favour of Indian Renewable Energy Development Agency Ltd. (IREDA) on 30.10.2003 for an amount of Rs.486500000/-

In this regard, it is clarified that M/s Sterlight Fincom Pvt. Ltd. has mortgaged one of its property in favour of IREDA, being promoter/director of the Borrower Company, as and by way of additional security (collateral security) equivalent to the value of Rs.400.00 lakhs for the term loan of Rs.486500000/- sanctioned to the IREDA Borrower. Therefore, appellant is correct that charge is registered by M/s Sterlight Fincom Ltd. in favour of IREDA. However, it is incorrect that the CPIO has stated false and incorrect information with apparent motives to deny and block the information to appellant as he has supplied the correct information based on the books of accounts of IREDA.

- 6) In the light of the above, I do not find any defect in the reply provided by the CPIO to the appellant. The appeal is disposed of accordingly. Copy of decision be sent to the Appellant as well as to CPIO.
