

ORDER

**FACTS:**

Shri Girish Mittal, filed an online appeal dated 30.01.2020 (Appeal Registration No.IREDA/A/E/20/00001) under the Right to Information Act, 2005 with the Appellate Authority against the reply of Central Public Information Officer (CPIO), IREDA Limited dated 20.02.201.

2) As per record available, the application of the appellant was registered as Application No.628 and CPIO has replied the same as per provisions of the Act, vide its letter dated 06.02.2019. The details of information sought by the applicant and information provided by the CPIO is as under:-

3) It is observed that the CPIO has examined the request made by the appellant based on the information available with him and have disposed-of the same within the stipulated time from the date of receipt of application, as per the provisions of the Act.

4) **GROUND OF APPEAL:**

The CPIO has sent a belated response to my RTI petition, which is clear violation of section 7(1) of RTI Act, 2005. And the Applicant has been provided list of entities which have been given sovereign guarantees by various ministries and departments of Govt. of India. If Finance Ministry can provide the information, why cannot IREDA. Also, there are various decisions of SC and HCs which have directed CPIOs to provide detail on how the exemption is applicable to them. The CPIO has quoted section 8(1)(d) verbatim, without explaining how the said exemption is applicable.





- ❖ The Applicant requests Appellate Authority and CPIO to read the decision of CIC in the case CIC/BS/A/2016/001647 - BJ wherein CIC has given detailed explanation of the various sections and decisions of the HCs and SC and revisit the response of the CPIO.
- ❖ There is wide public interest in making this information public.

**5) OBSERVATIONS:**

I have perused the information sought by the appellant and grounds of appeal referred as well as relevant provisions of the Right to Information Act, 2005. As per record, the CPIO has declined the information under Section 8 (1) (d) of the RTI Act, 2005 on the ground of commercial confidence, trade secrets or intellectual property, the disclosure of which would harm the competitive position of a third party, as enumerated in the aforesaid Section of the Act.

After going through the contents of the information sought by the appellant, in its original application as well as in the appeal, it is observed that the information sought by the Applicant has not been properly understood by the CPIO. Applicant sought the details of Sovereign guarantees issued by IREDA in favor of and on behalf of various entities.

The Applicant may note that Indian Renewable Energy Development Agency Limited (hereinafter referred to as 'IREDA') is Public Limited Government Company established as a Non-Banking Financial Institution in 1987 and works under the administrative control of Ministry of New and Renewable Energy (MNRE) and is not empowered to give any sovereign guarantee on behalf of Govt of India . No such guarantees have ever been issued by IREDA.

As far as belated response to the application of Appellant by the CPIO in reference to Section 7 (1) of RTI Act, 2005, it is observed that the RTI online portal of the CPIO was not working properly due to some technical snag at source due to which huge bulk of RTI applications were received in a single day which was disposed of on priority basis including the original application of the appellant.

**6) DECISION:**

With the above observations, the present appeal is disposed-off. A copy of the Order be sent to the Appellant as well as to CPIO.


