ORDER

Surya Prabha, hereinafter called the appellant, has filed an appeal dated nil received to us on 27.12.12 against CPIO,IREDA letter dated 31.08.12 read with letter dated 1.12.12 for not providing information within time prescribed under RTI as also incomplete and unsatisfactory information provided as sought for in her RTI application dated 24.07.12 received at IREDA on 01.08.12.

Aggrieved with the reply of CPIO,IREDA letter dated 31.08.12 read with letter dated 1.12.12, the appellant has filed the stated appeal.

However the information which is exempted under the provisions of RTI Act was withheld and I agree with CPIO,IREDA for not providing the same to the appellant. Further Pay Order No. 372815 dated 19.12.2012 of Rs. 10/- drawn on Andhra Bank is returned herewith.

8.0 Decision

- 7.0 As per the provisions of Sections 3 and 4(2) of Right to Information Act, 2005 and the objective of enactment of the said Act, the information desired by the Appellant is not exempted under Sections 8 (1)(e) and 8(1)(j) of the Right to Information Act, 2005.

8.0 Decision

- 8.1 Having considered the facts and circumstances and based on the documents mentioned above, the Appellant has already been provided the information permissible under the Right to Information Act, 2005.
- 8.2 There is no obligation under Section 8(1)(e) and 8(1)(j) of Right to Information Act, 2005 to provide you the other information which has fiduciary relationship and the personal information the disclosure of which has no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual. This was communicated to you by CPIO vide letter No. 216/94/MS/2005/IREDA/5279 dated 25th January, 2011.

Sir,

Kindly refer the above mentioned subject. I have not received the documents sought by me regarding my RTI Application I am constrained to submit that the desired information has not been provided to me by the CAPIO,IREDA citing Section 8(1)(j) which is quite arbitrary , discriminatory , just to deny information to the applicant.

To claim exemption under Section 8(1)(j), the CAPIO has to establish how the disclosure has no relationship to any public activity or interest $\,$. A mere conjecture or surmises $\,$ is not enough to deny information under Section 8(1)(j).

The CAPIO,IREDA misrepresented and denied information by very cleverly deleting the clause of Section 8(1)(j) <u>Proved that the information which cannot be denied to the Parliament or a State legislature shall not be denied to any person.</u>

Hence it is clearly evident that the CAPIO ,IREDA deliberately denied information to the applicant citing incomplete Section 8(1)(j) of the RTI Act,2005.

Information is a fundamental right of a citizen and denial of information can only be justified strictly in terms of Section 8(1)(j). The information cannot be refused until and unless it is clearly established that furnishing of information has no relationship to any public activity or interest.

It is therefore kindly requested to examine the entire files , papers documents etc related to my RTI application and direct the CAPIO,IREDA to provide me the desired information and also initiate suitable action against the CAPIO,IREDA for not providing information as per the provisions of RTI ACT,2005.
