

Notice to IREDA's Securityholders

Dividend/Interest Payments through Electronic Mode Only:

Pursuant to the recent amendments in SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the **dividend/ interest payments shall be made solely through electronic mode.**

The provision for remittance of dividend/interest **via physical instruments such as cheques or warrants has been removed** from the Regulations.

In view of the same, all the securityholders are requested to **update their bank account** details to ensure seamless credit of dividends/ interest, as follows:

1. For shares/bonds held in Demat form:

Please contact your Depository Participant (DP) to update your KYC and Bank Account details in your demat account.

2. For bonds held in Physical form:

Please contact the respective Registrar and Transfer Agent (RTA) of IREDA's bonds to update your KYC and Bank Account details in your folio by submitting the requisite documents.
