Selection Criteria of Projects to be Sanctioned under Supplementary Budget Subject: allocation of Rs. 140 Crore under National Bioenergy programme- reg.

Kindly refer the Ministry OM dated 16.09.2025 for administrative approval for supplementary budget of Rs.140 Crore for implementation of umbrella scheme of National Bioenergy Programme for duration of FY 2021-22 to 2025-26 (Phase-I). To sanction the projects under the supplementary funds it has been decided that the criteria will be followed to address the stubble burning and mitigate the air pollution in NCR region.

Accordingly, the following criteria will be adopted for sanctioning of the projects received under 2. National Bioenergy Programme to utilize biomass in the State of Haryana, Punjab, and NCR district of UP and Rajasthan.

Criteria 1: Type of feedstock

Priority 1 – Paddy Straw Based Project

Priority 2 – Other than Paddy straw Project

Criteria 2: Utilization of biomass per crore of CFA

i. Priority 1 – Torrefied Pellets

ii. Priority 2 – Non-torrefied pellets

iii. Priority 3 – Co-generation

iv. Priority 4 – CBG

Criteria 3: Commissioning status of the project:

Priority 1 – Commissioned Project

Priority 2 – Project Under Installation with Commissioning likely by the end of financial year.

- It is important to note that these criteria's will be utilized only for the purpose of sanctioning projects under additional budget of Rs.140 Crore under NBP Phase-I to facilitate effective stubble management.
- The guidelines, implementation framework, and the terms & conditions for the sub-components 4. of the National Bioenergy Programme shall continue to be applicable as prescribed under Phase-I of the Programme, along with any subsequent amendments issued from time to time under the respective components.
