This is in relation to the proposed initial public offering of equity shares of face value of ₹10 each by Indian Renewable Energy Development Agency Limited ("Company").

This is to inform you that the Board of Directors of the Company in its meeting held on November 11, 2023, approved the red herring prospectus dated November 11, 2023 ("RHP") in relation to the proposed initial public offering of its equity shares by the Company ("Offer"). The Offer is for up to 67,19,41,177 equity shares of face value of ₹10 each (comprises of a fresh issue of 40,31,64,706 equity shares and an offer for sale of up to 26,87,76,471 Equity Shares). The RHP has been filed with the Registrar of Companies, Delhi and Haryana on November 11, 2023. RHP has also been filed with the SEBI and submitted to NSE and BSE, for publication on their respective websites.

Additionally, in accordance with the applicable provisions of the SEBI ICDR Regulations, the Committee of the Independent Directors in their meeting held on November 13, 2023 has recommended the price band of ₹ 30 per Equity Share (Floor Price) - ₹ 32 per Equity Share (Cap Price), based on the quantitative factors and key performance indicators disclosed in the RHP ("Recommendation"), which has been subsequently approved by the board of directors on November 13, 2023. In terms of the SEBI ICDR Regulations, the Recommendation has been included in the price band advertisement and approved by the Board on November 13, 2023.

The IPO will be open for subscription by the public on Tuesday, November 21, 2023 and shall close on Thursday, November 23, 2023.
