Sub: Engagement of Advisor for Entity Specific Appraisals in IREDA

1. Introduction

Indian Renewable Energy Development Agency Limited (IREDA), categorized as a Navratna, is a Schedule 'A' Government of India Enterprise under the administrative control of Ministry of New and Renewable Energy (MNRE).IREDA is a Public Limited Government Company established as a Non-Banking Financial Institution in 1987 engaged in promoting, developing and extending financial assistance for setting up projects relating to new and renewable sources of energy and energy efficiency/conservation with the motto: "ENERGY FOR EVER".

The Entity Specific Appraisals play a critical role in assessing the financial and operational health of borrowers/group, ensuring robust risk assessment, and facilitating informed lending decisions. Given the evolving nature of renewable energy projects, emerging technologies and the diverse portfolios of borrowers, this system of appraisal will play a crucial role in assessing financial viability, governance standards and operational risks.

In the process of developing its Entity specific Appraisals to enhance its assessment and evaluation capabilities for project financing and risk assessment; IREDA intends to engage an Advisor for Entity Specific Appraisals to advice in financial analysis, credit assessment, and due diligence matters, inter-alia covering broad Scope of Work given in subsequent paragraph.

2. Scope of Work

- i. To assist in developing standardized appraisal methodologies.
- ii. To provide recommendations for improving credit risk management.
- iii. To assist in conducting financial and credit appraisals of entities applying for funding.
- iv. To support in assessing financial viability and risk factors associated with lending.
- V. To assist in financial modelling, due diligence, risk assessment, and provide advisory support of the division.
- vi. To support capacity-building initiatives.

The scope of work is indicative only and IREDA reserves the right to add/change the scope for the service, if necessary.

3. Eligibility Criteria & Other Conditions

Qualification	The Candidate should be CA, CMA, MBA, CAIIB or equivalent qualification
Experience	The Candidate must have minimum 25 years' experience out of which minimum 3 years in entity appraisal work at General Manager/E-8 level or above in any Schedule A & B CPSE or at equivalent level in NBFC/Bank. The CPSE/NBFC/Bank should be having turnover of more than Rs. 5000 Crore.
Age	The Candidate should be above 50 years and below 62 years of age, as on date of application.

Period of Engagement	The advisor shall be engaged initially for a period of one (01) year from the date of engagement, which can be extended depending upon the performance and organizational requirement.
Remuneration	Professional Fee of Rs. 6,000/- to Rs. 7500/- per day based on the profile (Payable on monthly basis on self-certification basis, as per guidelines)
Reporting to	Director (Finance)
General Condition	The candidate should be clear from Vigilance point of view from all the employer organization(s) in which he/she has served for last ten years.
