#### 8. Evaluation and Further Process:

- I. All submitted proposal received till end of expiry date shall be evaluated by internal committee for responsive ness.
- II. For all proposals found eligible; their authorised representatives shall be informed for schedule of the opening of financial proposals. Financial proposal shall be opened in the presence of available representatives of qualified bidders as per notified schedule.
- III. Eligible bidders whose proposal is found H1 shall be declared as successful base bidder and their price offered as base /anchor bid after due approval of competent authority.
- IV. Successful bidder shall be responsible for purchasing the asset by paying full consideration price quoted in their offer subject to their eligibility under terms and conditions of auction under Swiss challenge process to be conducted later.

## V. Auction Process with Swiss challenge:

- a. IREDA shall initiate e auction of the assets (PURCHASE OF MOVABLE & IMMOVABLE ASSETS OF M/s SIVA RENEWABLE POWER & ENERGY LTD UNDER SARFAESI ACT) after issue of the sale notice for e auction as per applicable timelines.
- b. E auction shall be conducted with existing base bid offer in hand as reserve price & under Swiss challenge to existing base bidder as follows.
- c. E auction shall be conducted in regular mode for determination of Highest bid (H1) offer from market participation in e auction, including participation of base bidder.
- d. Right to Match: Limited Right to match provision shall be available to base bidder subject to outcome of the e auction.
- e. Upon conclusion of first e auction, base bidder shall be provided right to match subject to H1 offer discovered during regular e auction is up to 20% above the reserve price any other party. Base bidder shall be provided limited time e-auction participation in order to bid under Right to match.
- f. In the event e auction H1 discovered price is above 20% of Reserve Price of auction, highest offering bid i.e. H1 bidder during the Swiss challenge shall be considered final successful bidder and no right to match shall be activated.
- g. EMD of the final successful bidder shall be retained against initial payment

and sale certificate shall be issued by IREDA to final successful bidder with instruction to deposit 15% of the bid amount within 1 day and remaining payment within 15 days of issue of sale confirmation.

- VI.
