II. General Instructions

This Pre-bid meeting will be conducted virtually with Microsoft Teams as the conferencing medium.

- Please ensure that you have access to Microsoft Teams and your system configuration is compatible for Microsoft Teams.
- Please ascertain that you have enough internet bandwidth to participate in Pre-Bid conference without experiencing any attenuation.
- You need to have one Microsoft ID /Outlook ID for registering on Microsoft Teams
 Platform. In case, you don't have any, you are requested to sign up for an account
 beforehand.
- Maximum of two persons from one bidder will be allowed to attend the meeting.
- Please enter your name into the meeting in below format. Person Name_Company
 Name
 - o e.g. Mr. John Smith from ABC firm should enter his name as JohnSmith ABC
- All participants will be on default mute during the first three sessions listed in agenda.
- Queries will be answered to the bidders in the alphabetical order of their respective company's name.
- Initially every bidder will be allotted a slot of 10-15 minutes in which he/she is allowed to ask five important pertinent queries which will be answered, if not done already, during the meeting or along with pre-bid queries. If time permits and if there are any further queries, they can be taken up in the same fashion by giving 5-10 minutes' slot to bidders.
- If all the participants of the same bidder are sitting in the same room or in close proximity, then they are requested to mute the microphone of all the devices expect one, as that creates echo of sound and increases the noise level in the meeting.
- Bidders are requested to join the virtual meeting room 15 minutes in advance i.e. at 02:45 PM so as to allow sufficient time to the meeting host to admit them in the meeting.
