1. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Generic

Buyer Organization specific Integrity Pact shall have to be complied by all bidders. Bidders shall have to upload scanned copy of signed integrity pact as per Buyer organizations policy along with bid. Click here to view the file

4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Experience -

- a) The bidder must have at least 7 years of experience in consulting services in India
- b) During the last 7 years, the Bidder must have completed or substantiall y completed (where at least 80% payments must have received), at least seven consultancy assignments in India
- c) Out of the consultancy Assignments mentioned above, 2 assignments s hould be "Similar Assignments" in India

Definition of "Similar Assignments" shall mean assignments fulfilling all the below mentioned three criteria:

i. Assignments with the scope of work of providing Strategy Consulting or Strate gy Advisory Services to Clients engaged in energy transition areas, including Re newables, Gas, Biofuels, Green Hydrogen and its derivatives, Carbon Capture, E nergy Storage, Energy Efficiency, E-Mobility, E-Mobility-related Charging Infrastr ucture, Smart Meters, Renewable Energy Manufacturing (including Battery, Battery Energy Storage Systems).

ii. The assignments in the above domains should have been conducted for the following Clients:

CPSEs/ State PSEs/ Public and Private companies operating in India and having an average audited annual turnover of Rs. 5000 crore or more in last three (3) years.

Or

Central Government or State Government authorities or autonomous bodies of Central/State Government in India.

Each consulting assignment should have a value of Rs. 1 Cr. or more (including taxes).

2. Financial Capability -

Turnover: The Bidder must have an average audited annual revenue of Rs. 40 crores (Rs. Forty crores) for the last seven years i.e. (FY 2025, FY 2024, FY 202 3, FY 2022, FY 2021, FY2020

and FY 2019), out of which at least 50% revenue should come from Consultan cy Service Contracts (total payments received for contracts in progress or completed), within the last seven years.

Note: In case FY 2025 audited annual reports are not available, then FY 2024, FY 2023, FY 2022, FY2021, FY 2020, FY 2019,

FY 2018 audited annual reports can be considered. In case the reporting is on calendar year basis, same may be considered.

Net Worth: The Net Worth of Bidder firm should not be negative as on end of the immediately preceding financial or calendar year and should not have eroded by more than 30% in the last 3 years.

6. Purchase Preference (Centre)

Bid reserved for Make In India products: Procurement under this bid is reserved for purchase from Class 1 local suppliers as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document 50%. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
